		Copies of all Paystubs within 60 days of the filing
		Copies of all monetary contributions by those in family or otherwise within 60 days of the filing
		Documentary proof of all secured ongoing expenses such as mortgage and car payments.
		Documentary proof of all claimed exemptions. Proof may include current tax bills, titles to motor vehicles, insurance policies.
		A detailed inventory, including the age and estimated value of all personal property. Personal property includes, but is not limited, to jewelry, furniture, electronics, antiques, collectables, musical items, hobby and exercise equipment, and all intangible property. PHOTOGRAPHS are also Recommended.
		Copies of all bank account statements, including but not limited, to savings and checking accounts, for the 60 days.
		Copy of the Debtor's Certificate of Credit Counseling
		Documentary Proof that the debtor has resided in Florida for the 730-day period immediately preceding the filing or a copy of the exemptions for the state to which the debtor resided for the 180 days previous thereto
		Documentary Proof that the debtor is entitled to 100% of the Florida exemptions <i>if the debtor purchased the homestead within 1215 days of the petition</i>
		Documentary proof of the value and payoff amount for the Debtor(s) homestead if purchased within the 1,215-day period immediately preceding the filing of the Petition
